All ERKA reusable cuffs may be disinfected thoroughly by spraying or wiping with tested approved disinfectants. Afterwards the surface is wiped with light pressure.

#### WHY ALL ERKA GREEN BLOOD PRESSURE CUFFS ARE SO PLEASANT TO USE?

The optimal comfort is determined by the combination of materials used and the complete absence of PVC , DEHP and similar substances. Furthermore, our materials are biocompatible and satisfy the requirements specified in DIN ISO 10993.

#### HOW TO PLACE THE ERKA CUFF CORRECTLY?

To avoid any error the cuff must be placed correctly. The brachial artery is clearly marked on all ERKA cuffs: it is a reliable indicator for positioning the cuff.

#### HOW TO CHOOSE THE CORRECT SIZE OF THE CUFF?

All ERKA GREEN CUFFs are clearly marked with a size range. One must choose a different cuff size if the arm circumference does not fit into one of the ranges.
